

#CarFreeMSP Terms and Conditions

1. Eligibility: The #CarFreeMSP contest is open to legal residents of the United States who participate on the social media platforms of Facebook, Twitter, or Instagram. Entrants may also enter via email correspondence. Entrants must be 18 years of age or older as of their date of entry in this promotion in order to qualify. The #CarFreeMSP Contest is subject to federal, state, and local laws and regulations and void where prohibited by law. Move Minnesota and Move Minneapolis's employees, its subsidiaries, affiliates, suppliers, partners, advertising and promotion agencies, and directors (collectively the "Employees"), as well as members of an Employees' immediate family and/or those living in the same household of Employees are ineligible to participate in the #CarFreeMSP contest.
